**NOTIFICATION**

**Participation in "Swachhata Hi Sewa Campaign"**

1. 'Swachhata Hi Sewa Campaign' is being launched by the Govt of India from **11 September 2019 to 02 October 2019**, with the aim to eliminate use of plastic and to dispose plastic waste. In view of the same, following measures will be undertaken:-

(a) Use of single use plastic is hereby banned with immediate effect in the University Campus (Administrative Building, Departments, Offices, Hostels, Residential areas, all Canteens including Indian Coffee House, all Shopping Complexes etc), also in other Premises of the Vishwavidyalaya in Sagar City.

(b) Also all Deans/HoDs/Teachers/DoSA/Proctor/Wardens are requested to educate and mandate the students to avoid bringing non bio-degradable plastic items in the Vishwavidyalaya.

2. All Deans/Directors/HoDs/Proctor/Wardens/UE/Med Officer are requested to ensure the compliance in letter & spirit, as applicable to them.

3. **DoSA & Proctor only.** UGC letter dated 30 August 2019 alongwith its enclosure is attached for reference and necessary action, i.e implementation of points at S.No. 2(a) & 2(b) in letter D.O. 


